Taking existing businesses to the next level Strategic Growth for Second-Stage Businesses

NetWork Kansas announced recently that there are openings for businesses to participate in the Kansas Economic Gardening Program. Thanks in part to a grant received from the Kauffman Foundation to facilitate business assistance projects in Kansas, twenty (20) second stage businesses will be sent through the Kansas Economic Gardening program. There is no cost to the business. This program helps businesses grow intentionally by connecting them to a team of trained research analysts. Each company will receive individualized data specific to their business' strategic needs.

"Economic Gardening is an innovative, entrepreneur-centered, growth strategy focused on providing tools to cultivate second-stage businesses," said Steve Radley, President & CEO of NetWork Kansas. "These are companies that are actively growing and ready to take their businesses to the next level."

enue and second-stage companies nationwide reported a .5% increase in revenue.

"With access to critical research and other tools to grow our business, we have really fine-tuned and realigned our sales approach," said Curtis Whitten, President & CEO of VendTech Enterprises. "I still can't believe there were no costs for this information! I'm confident we will see a major impact on our revenues."

To be eligible, companies must be a second-stage business headquartered and operating in Kansas for at least the past two years. The businesses' annual revenues should be \$500,000 to \$50 million and have five to 100 current employees. They must demonstrate some form of growth in employment or revenue in two of the past five years. Additionally, these businesses must provide products(s) and/or services outside the current service area to regional and national markets.

Local Businesses Participated in WSU's "Growing Rural Businesses Entrepreneurial Program"

Wichita State University's Center for Entrepreneurship, in partnership with the McPherson Chamber of Commerce and NetWork Kansas, presented the entrepreneurial certificate program "Growing Rural Businesses" in McPherson, Kansas. Fourteen businesses from McPherson County participated in the course. This 8-week course is custom-made to meet the needs of existing rural business owners who are ready to grow.

The outcomes of this course include indepth knowledge of practical solutions and techniques to grow and modernize business ventures while living in a rural setting. Insights and learning tools included small group exercises, case studies, and interac-

tive discussions with peers, facilitators, and industry experts. As a result, these entrepreneurs have a much deeper understanding of running an efficient rural business.

Leadership McPherson Growing McPherson's Network of Experienced Leaders

Enrollment for the 2017 Leadership McPherson program will begin February 1, 2017. The McPherson Chamber of Commerce has offered the professional development program since 1982. Leadership in a community is vital to its ongoing success and that is why the Chamber provides it as one of its initiatives.

* Who is the ideal participate? Anyone who wants a broader and deeper view and role in our community would be a great candidate for Leadership McPherson.

• Why should you should participate or support an employee to participate? The community wins and as an employer you win. Graduates from Leadership McPherson have a clearer focus on how and where their efforts contribute to McPherson's success. Making connections to others in the program, employees tend to be more committed to the community they work in, and graduate with more confidence and skills they can utilize in the workplace, home and in the community.

 What makes Leadership McPherson different than other programs? Participants benefit from interactivity, involvement, a large alumni network and the Chamber's 34 year experience.

 How many are in the class and what's the cost? There is a minimum class of 12 members and maximum of 16. The cost is a very reasonable \$300 for Chamber investors and \$350 for non investors. The tuition covers all expenses - overnight retreat, supplies, meals, etc. There is limited financial assistance available for partial tuition. What are the expectations of participating? Your success and that of those learning with you requires complete commitment and participation. We have high expectations of each participant during the class sessions and after the training program. We ask that you make a personal commitment to become involved in your community. You will learn more about yourself and recognize talents, skills and strengths you never new you had. You will discover new traits to celebrate and appreciate in others as well. Together, you will gain more confidence and become empowered. Leadership McPherson program consists of a class reception, a very important required one day and a half overnight retreat, and 8 half day sessions. At the conclusion of your leadership training, the class will participate in deciding and executing a class project that benefits the youth of McPherson. The planning and executing of the class project may require time outside of the class sessions. The program runs from April 20-July 26. One excused absence is allowed.

Kansas companies who participated in an earlier pilot of the Kansas Economic Gardening program experienced an increase in annual revenues during a two-year period of more than \$30.3 million at an average annual growth rate of 16.1%. During the same time period, other second-stage Kansas companies only reported a 2.1% increase in rev-

E-Loan Fund is Driver in Start-Ups & Expansions

The McPherson Chamber of Commerce Entrepreneurship Loan Fund started in 2011. Through a long application process to Network Kansas, McPherson County was awarded the "Entrepreneur Community" designation. With the E-Community designation, it allowed the Chamber to sell tax credits allowing individuals to offset their tax liability while creating economic opportunities for the county. The tax credits then provides a loan pool to aid in assisting funding business startups, expansions, working capital, inventory, etc in McPherson County

The program works like this: Example: Assume an applicant needs a total of \$60,000 - project must be located within McPherson County. Also assume the applicant is providing \$10,000 of their own capital. Of the remaining \$50,000 needed, the E-Community can provide no greater than 60% of the gap (in this case the funds could be no more than \$30,000 of the \$50,000 needed). The other 40% minimum (in this case \$20,000 minimum) must come from a bank, financial institution and/or other public funding sources. This is not a direct loan fund, the Chamber is a partner in the investment of entrepreneurship therefore a financial institution must be involved in the funding process.

Since the inception of the McPherson County Entrepreneurship Loan Fund program in 2011, there has been a total of 33 loans (32 in City of McPherson 1 in Lindsborg) totaling \$1,065,471 towards projects of \$6,401,725 million creating 144 jobs. The Chamber is proud to have partnered with First Bank Kansas, Home State Bank, Peoples Bank & Trust, Farmers State Bank, Emprise Bank, Sunflower Bank, South Central Kansas Economic Development Division, McPherson County Small Business Development and McPherson Main Street to support entrepreneurship growth in McPherson County.
