2021 President's Award Honoree is Making a Positive Difference

David O'Dell was presented the 2021 President's Award during the 100th McPherson Chamber of Commerce Annual Meeting. The honoree is selected each year by the Past Presidents of the McPherson Chamber, to recognize "an individual that has given unselfishly of their time for the betterment of the business community, is readily identifiable, and has had a long-term impact." Chet Lang, 2004-2005 Chamber President shared many accolades about David, then turned over the microphone to hear from our humble recipient.

During his remarks, President's Award recipient David O'Dell mentioned that his father, Ivan O'Dell, had also received this award in 1976, but the award at that time was called the Man of the Year Award. David had with him the small statuette that was presented to his father at that time and said that he was honored and humbled to be able to follow in his father's footsteps in this manner. David O' Dell concluded his remarks with this quote from Peter Drucker, "Our mission in life is to make a positive difference, not to prove how smart we are." O'Dell added, "In order to keep McPherson moving forward, I urge you to make a positive difference."

David was born and raised in McPherson, attending Wickersham Elementary and graduating from McPherson High School in 1968. He graduated from McPherson College BS in Business and several years later returned to school for further education and graduated from Emporia State University with an MBA (1985). He passed the CPA exam in 1978. During his senior year at McPherson College, he was hired by Keith G. Mines, CPA as Keith's first employee. After eleven years with Keith David felt called to teach at McPherson College and start his own CPA practice. David retired from McPherson College in 2019 after 40 years of teaching with the Rank of Full Professor. David sold his CPA firm after 33 years of practice. He continues to work during tax season for Adams Brown, CPA firm. Next tax season he will "celebrate" 50 years of tax seasons.

During college David met Jaymie at a local church. They were married in December 1970 and recently celebrated 50 years of marriage during COVID by co-teaching a Marriage Class at their church, Countryside Covenant Church. David, his family and many, many friends will miss Jaymie as she unexpectedly passed way September 1st.

I00 Years Strong Chamber History Stories 2005 Inaugural Year of Brush Up Mac

In the April 2001 edition of The Chamber Outlook, it included an article titled "Housing Committee Organizes City Cleanup & Brings Landlords Together." It talked about the cooperative effort of so many agencies and citizens to rid properties of unwanted trash and recyclable items, to beautify McPherson. The article also indicated that "the Housing Committee invited McPherson landlords to explore the possibility of forming an association for the purpose of providing insight into shared needs and concerns and develop cooperative efforts and programs to enhance the quality and quantity of rental housing stock. Those who attended represented almost 400 rental units."

An article in the McPherson Sentinel on December 31, 2004, referred to Brush Up Mac, "New program expected to provide a service that will impact the community." Bonnie Hoffman, committee member at that time, said the McPherson Chamber of Commerce Housing Committee had been meeting for 8 years when they reevaluated their mission of revitalization and decided to "start this project by redoing a house."

The Housing Committee put their plans into action in April of 2005, the inaugural year of Brush Up Mac, and worked on rehabilitating seven McPherson homes with the help of sponsors and 90 volunteers. The program was closely modeled on Rebuilding Together, formerly known as Christmas in April, a national organization that helps low-income families, veterans, and the elderly with free home modification services.

Fast forward to 2011, the McPherson Housing Coalition took on the implementation of Brush Up Mac and has done a tremendous job of helping homeowners in need. The following information came from their website, "Over 1,000 families have been helped through Brush Up Mac since it started in 2005. Many people struggle to make repairs and do upkeep on their homes, especially those who are elderly or disabled. Homeowners who are physically or financially unable to make improvements to their homes benefit from this program, which sends out more than 300 volunteers every spring to help them out." Business & Industry Wall of Honor

"We enjoy the quality of community we have because of the vision and creativity of many local business leaders past and present," was a comment recorded in 2001 from Joe Pavlovsky the 2000/2001 Chamber President. To recognize long appreciated business and industry leaders who have made a significant contribution to the community, the Chamber planned a luncheon ceremony and presented each honoree with a plaque to be displayed on the McPherson Chamber of Commerce Business & Industry Wall of Honor.

John Bremyer, Fred Diehl, M. Clare Miller and Keith Swinehart, Sr. were the first inductees. Two of the four inductees were recognized posthumously, and their families were invited to accept the awards during the inaugural luncheon on April 17, 2001. "This is a very special occasion," said Joe Pavlovsky, and "…it is important that we let this community know and appreciate the contributions of those we honor. It also allows us to say thank you to those of you who are filling their shoes today."

The April 2001 Chamber Outlook publication said Bob Wise was the master of ceremonies for the induction, and he "was privileged to have witnessed the vision and daring of the men being honored. All possessed the capacity to see into the future and the fortitude to do what they thought best for McPherson."

The McPherson Chamber of Commerce Business & Industry Wall of Honor plaques are still proudly displayed at the Chamber office, at 306 N. Main. Business Start-Ups, Successions, and Expansions

The McPherson County Entrepreneurship Community loan program is an amazing partnership with NetWork KS to provide gap financing for businesses startups, successions, and expansions. Since 2012, the McPherson County E-Community Program administered by the McPherson Chamber of Commerce has approved 61 low interest e-community loans, totaling over \$2.4 MILLION dollars! That investment also results in more jobs and continued growth for our community

Although there is a limited amount of funds available, we are excited about the recent activity.

The E-Community Loan Program is gap financing, to help bridge the gap of a bank loan and bring these business dreams to reality. Since January 2021 we have helped fund the following business ventures; Crew Nutrition, 206 S. Centennial Dr., Farley's Bar & Grill (Lindsborg), McPherson Classical Coaching Academy, 206 N. Main, and The Ark Antiques and Flea Market, at 301 S. Main St.

The Virtual United Way Campaign

Way campaign in McPherson County virtually. We typically had an in-person event to celebrate the campaign, but as we approach the COVID-19 variant wave with caution, we took the safe route again this year.

Normally we see a lot of people during the United Way

For the second year in a row last month, we kicked off the United

campaign, going out to companies and talking to employees about the many ways their gifts stay in the county and help improve lives through our 17 nonprofit programs. We are still available to do that but it's more likely this year we will be using technology to tell our

story, not to mention the many people who are currently working from home.

Most of the money pledged during the annual campaign comes through payroll deduction. It's usually easier to give something out of each paycheck. You don't see it or feel it much, but when you add it all together, it really does make a difference. Then consider we have several companies that match their employee contributions, which doubles the impact. And we also have a robust group of retirees and self-employed who are there for us year in and year out contributing to United Way.

Running our campaigns virtually means we share videos of how our partner agency programs are making a difference. It may mean getting an email rather than a paper brochure telling you how United Way works.

Not that a virtual campaign is a bad thing. Last year during the pandemic, our campaign raised \$310,166.68- an all-time record. That's to the credit of all our donors. As this year's Campaign Chair Ronda Sjogren said of 2020, "It's amazing how people have such a giving spirit when we're in a time of need." And we did respond to community need, helping more than I40 families with rent and utility assistance during the worst of the pandemic.

This year's campaign goal is \$275,000. On the heels of a record campaign, Sjogren said "we wanted to set an attainable goal, but yet something that wasn't unreachable."

During the kickoff last month, United Way announced its company awards from the previous year's campaign.

- Farmers Alliance Mutual Insurance and its employees received the Legacy Award for its record-setting campaign of more than \$126,000 during the 2020 Campaign.
- CHS won the Mega-Match award by generously matching each dollar contributed by employees with an additional \$1.50.
- The Rising Impact Award went to employees of BPU, The Board of Public Utilities. They increased their giving by 87%.
- Dillons employees received the Inspired Giving Award with a 67% giving increase.
- Rise Private Wealth Management received the Small but Mighty award for its support of United Way and Dolly Parton's Imagination Library.
- Wabtec of McPherson wins the award for New Employee Campaign.
